आपल्या दिनांक 03/07/2023 च्या अर्जाच्या संदर्भात आणि त्यानंतर या संदर्भात शाळेची केलेल्या पत्रव्यवहार शाळेची कलनी तपासणी या आधारे मी शिक्षणाधिकारी (प्राथमिक) पुणे जिल्हा परिषद पुणे दिनांक 1 April 2023 पासून 31 March 2026 पर्यंत तीन वर्षांच्या कालावधीसाठी इयत्ता 1 ते 8 करिता The Archangel Education Foundation संचलित Kunjir Public School, Sr.No,7/2/2,Kunjir Vasti,Manjari, Pune UDISE क्रमांक 27250509222 (स्वयं अग्रेसर/राष्ट्रीय-English माध्यम STATE\_BOARD) शाळेस तात्पुरती मान्यता देत आहे.

वरील मान्यता ही म्यालील शर्तीच्या पूर्ततेच्या अधीन आहे

- मान्यतेचा कालावधी वाढवून मिळणार नाही आणि इयत्ता आठवीनंतर मान्यता किंवा संलग्नता देण्यास कोणत्याही परिस्थितीत कोणतेही बंधन नसेल.
- बालकांना मोफत व सक्तीच्या शिक्षणाचा अधिनियम, 2009 (जोडपत्र एक) आणि महाराष्ट्र बालकांना मोफत व सक्तीच्या शिक्षणाच्या हक्क नियम, 2011 (जोडपत्र दोन) मधील तरतुदींचे शाळा पालन करील.
- शाळा नजीकच्या दुर्बल घटकातील आणि वंचित गटातील बालकांना, पहिल्या इयत्तेत, त्या इयत्तेतील विद्यार्थी संख्येच्या किमान 25% मर्यादेपर्यंत प्रवेश देईल आणि प्राथमिक शिक्षण पूर्ण होईपर्यंत त्यांना मोफत व सक्तीचे शिक्षण देईल परंतु आणखी असे की, पूर्व प्राथमिक इयत्तांच्या बाबतीतदेखील या प्रमाणकाचे अनुपालन करण्यात येईल.
- परिच्छेद 3 मध्ये निर्दिष्ट केलेल्या बालकांकरिता शाळेला अधिनियमाच्या कलम 12 (2) नुसार प्रतिपूर्ती मिळेल, अशी प्रतिपूर्ती मिळण्यासाठी शाळेला स्वतंत्र बँक खाते देण्यात येईल.
- सस्था / शाळा कोणतेही कॅपिटेशन फी वसूल करणार नाही आणि कोणत्याही छाननी पद्धतीसाठी बालकास किंवा त्याच्या किंवा तिच्या माता-पित्यास किंवा पालकास भाग पडणार नाही.
- कोणत्याही बालकास वयाच्या पुराव्याच्या अभावी; धर्म, जात किंवा वंश, जन्मठिकाण किंवा यापैकी कोणत्याही कारणास्तव शाळेमध्ये प्रवेश नाकारता येणार नाही.
- (एक) शाळेत प्रवेश दिलेल्या कोणत्याही बालकास तो ज्या इयत्तेत असेल त्याच इयत्तेत रोखून ठेवले जाणार नाही किंवा प्राथमिक शिक्षण पूर्ण होईपर्यंत शाळेतून काढून टाकण्यात येणार नाही.  
(दोन) कोणत्याही बालकास शारीरिक शिक्षा किंवा मानसिक त्रास देण्यात येणार नाही.  
(तीन) कोणत्याही बालकास प्राथमिक शिक्षण पूर्ण होईपर्यंत कोणत्याही मंडळाची परीक्षा उत्तीर्ण होणे आवश्यक धरणात नाही.  
(चार) प्राथमिक शिक्षण पूर्ण केलेल्या प्रत्येक बालकास नियम 23 अन्वये निर्धारित कालावधीत प्रमाणपत्र देणेत येईल  
(पाच) बिकलांग विशेष गरजा असलेल्या विद्यार्थ्यांच्या अधिनियमाच्या तरतुदीनुसार समावेश करणेत येईल.  
(सहा) अधिनियमाच्या कलम 23 (1) अन्वये निर्धारित केलेली किमान अर्हता धारण करणाऱ्या शिक्षकांची नियुक्ती करण्यात येईल परंतु आणखी असे की, अधिनियमाच्या प्रारंभाच्या दिनांकास किमान प्रत्येक धारण न करणाऱ्या शिक्षकांना अर्जा किमान अर्हता 5 वर्षांच्या कालावधीत संपादन करावी लागेल.

Subject: Regarding the issuance of a Recognition Certificate to private schools under Section 18 of the Right of Children to Free and Compulsory Education Act, 2009, and Rule 11, Sub-rule (4) of the Maharashtra Right of Children to Free and Compulsory Education Rules, 2011.

Reference: Report of Nilima Mhetre, Extension Officer (Primary), Pune Zilla Parishad, following the online RTE inspection dated 24/08/2023.

With reference to your application dated 03/07/2023 and subsequent correspondence/school inspection, I, the Education Officer (Primary), Zilla Parishad Pune, hereby grant temporary recognition to Kunjir Public School (UDISE No. 27250509222), English Medium, STATE BOARD, for classes 1st to 8th for a period of three years from 1st April 2023 to 31st March 2026.

The above recognition is subject to the fulfillment of the following conditions:

The recognition period will not be extended, and there is no obligation to grant recognition or affiliation beyond class 8th under any circumstances.

The school shall abide by the provisions of the Right of Children to Free and Compulsory Education Act, 2009 (Appendix 1) and the Maharashtra RTE Rules, 2011 (Appendix 2).

The school shall admit children from disadvantaged groups and weaker sections in the neighborhood to the extent of at least 25% of the strength of class 1, and provide them free and compulsory elementary education till its completion.

To receive reimbursement for the 25% admissions under Section 12(2), the school shall maintain a separate bank account.

The school/society shall not charge any capitation fee and shall not subject the child or his/her parents/guardians to any screening procedure.

No child shall be denied admission on the grounds of lack of age proof, religion, caste, race, place of birth, or any such reasons.

(i) No child admitted shall be held back in any class or expelled from school till the completion of elementary education.

(ii) No child shall be subjected to physical punishment or mental harassment.

(iii) No child is required to pass any board examination till the completion of elementary education.

(iv) Every child completing elementary education shall be awarded a certificate as laid down under Rule 21

(v) Students with disabilities/special needs shall be included as per the provisions of the Act.

(vi) Teachers shall be appointed with minimum qualifications as per Section 23(1).

The school shall follow the syllabus prepared on the basis of the curriculum laid down by the appropriate authority.

The school shall admit students in proportion to the facilities available in the school as prescribed in Section 19 of the Act.

10. The school shall comply with the standards and norms specified in Section 19 of the Act. The facilities available at the school during the last inspection were as follows:

- \* Total Campus Area: 8093.713 Sq. M.
- \* Total Construction Area: 2787.091 Sq. M.
- \* Playground Area: 5306.694 Sq. M.
- \* Number of Classrooms: 22 Classrooms
- \* Office-cum-Store-cum-Headmaster's Room: 7 Classrooms
- \* Separate toilets for boys and girls with adequate water for cleanliness and hygiene:
- \* Toilets (WC): Boys: 10, Girls: 10
- \* Urinals: Boys: 10, Girls: 10
- \* Drinking water facility: Yes
- \* Kitchen for cooking mid-day meals: No
- \* Availability of Teaching-Learning Material (TLM), Sports Equipment, and Library: Yes
- \* Reading material available free of cost: (Library books: 3500, Periodicals/Newspapers: Sakal, Times of India, Pudhari: 3)



No unrecognized classes or divisions shall be run in the school premises or elsewhere in the name of the school.

The school building or other structures and the playground shall be used only for the purpose of education and skill development.

The school is run by a society registered under the Societies Registration Act, 1860 (21 of 1860) or the Mumbai Public Trusts Act, 1950.

The school is not run for the profit of any individual, group, or association of persons.

The school accounts should be audited and certified by a Chartered Accountant and proper accounts statements should be prepared as per rules. A copy of each audit statement should be sent to the District Education Officer every year.

Your school has been allotted UDISE No. 27250509222. This number must be mentioned in all correspondence with this office.

The school shall submit reports and information as required by the Director of Education / District Education Officer from time to time and comply with instructions issued by the State Government or local authority for continued fulfillment of recognition conditions or removal of deficiencies in school operations.

Renewal of registration of the society must be ensured.

Other conditions as per "Annexure 3" are attached herewith.
